- I agree that the adoption fee helps to cover the CCSPCA's expense of caring for this cat/kitten and is NOT REFUNDABLE
- I hereby understand and agree that the CCSPCA makes no representations or warranties, expressed or implied, about this cats temperament and health (INCLUDING RABIES) and is hereby absolved from any liability for future damages or injuries caused by this cat/kitten.
